Take Beltway 495 North to 270N.

Take Montrose Road Exit. At light at exit, turn left on Montrose Road. Next traffic light, turn right on Seven Locks Road. Next traffic light, turn left on Falls Road. Next traffic light, turn right on Richie Parkway.

Take the 4th left turn onto Scott Drive. (A sign will say no trucks - restricted bridge ahead. If you pass the high school, you've gone too far!) Go over the wooden bridge (single lane) to next stop sign. Turn left onto Overlea Drive to 9211. (First driveway on left.)
