Fellow PVS'ers:

Some concerns have recently been expressed by PVS members about the future of PVS and about possible changes in the operations of the club. I want to assure you that major changes in our beloved PVS have not occurred, nor are they contemplated. What our club leadership has done is to respond to an issue that potentially affects all of us concerning the financial health and business viability of the tour operators that we use to run our ski trips. The entire travel industry is experiencing significant problems these days, and bankruptcies of tour operators are not uncommon. Of concern to EXCOM was whether the current environment in the travel industry posed undue risks for the club and for our trip participants. EXCOM's concern was heightened by the recent legal problems of Group Trips Unlimited, the current BRSC wholesaler. Because of these concerns, EXCOM reviewed the management of PVS trips, and concluded that steps should be taken to ensure that money paid by trip participants was protected to the maximum possible extent. Some of the possibilities considered by EXCOM included insurance coverage, changes in how PVS contracts with tour operators, and the establishment of escrow accounts to provide security for trip monies. In doing its research, EXCOM members sought information from tour operators, other ski clubs, and PVS trip leaders. Because of the complexity of the issue a special gathering of EXCOM members was held to exchange information and ideas. At its regular May meeting, EXCOM voted to adopt a procedure whereby PVS trip leaders will be involved in the disbursement of trip funds to hotels and other vendors. This procedure will provide a significant measure of security for trip participants' money. It will also help to prevent problems from occurring during a trip.

I want to commend the members of EXCOM for having recognized a potential problem in advance of any real problem, and for coming up with a reasonable and effective solution.

I hope you find this information helpful. Let me close by saying that your PVS leadership is committed to preserving the fundamental personality and character of this great club.

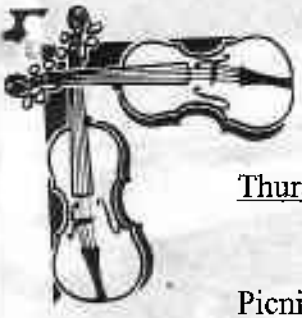

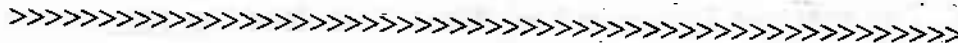

Report to the golf clubhouse by 12:30 where we will form foursomes and start off at 1 P.M.



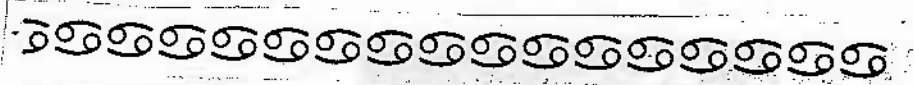
Coffee with Richelieu

Excom Excerpts

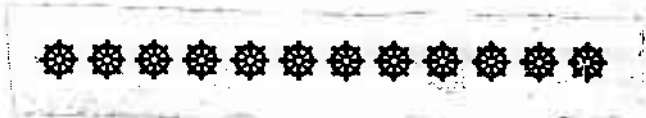
At its June meeting, the Excom deliberated next years BRSC/PVS trips to Tahoe and Innsbruck. This was occasioned by the recent conviction of Judy Miller of Group Trips Unlimited (GTU), the tour operator for both trips. Based on this information, Excom decided to withdraw its earlier approval of both the Tahoe and Innsbruck trips. This decision may be reconsidered if BRSC replaces GTU with another tour operator.

STEAMBOAT SPRINGS, CO. Tues. Dec. 10 - Tues. Dec. 17, 2002

Long a PVS favorite, this trip to the ski-in/ski-out Sheraton Steamboat Hotel is being led by Sally Finan and George Welti. It will include: Air fare Washington/Dulles to Denver and return; Ground transfer Denver to Steamboat Springs and return, 7 nights lodging @ Sheraton Hotel (ski-in/ski-out), Baggage handling, Wine-and-cheese reception, 5-day ski-lift pass, 7 breakfasts, 3 apres ski parties, 3 dinners out, Pre- and post-trip parties. BIO OF NEW EXCOM MEMBER – JOHN H. SMITH

John Smith I was born in Rome, N. Y., but grew up for most of my childhood in Phillipsburg, N.J. He received both a B. S. degree in Metallurgy and a B. A. degree from Lafayette College in Easton, PA. He then received an M. S. from the Missouri School of Mines in Rolla, MO. and an Sc.D from M.I.T. in Cambridge, MA.

Prior to coming to Washington in late 1974 to work in the Metallurgy Division at the National Bureau of Standards, (now called the National Institute of Standards and Technology), he was in the Army in Cleveland, OH. and worked for U.S. Steel in Pittsburgh, PA. He retired from NIST in 2000 and is now actively involved in consulting engineering practice.

We live in Potomac and joined PVS in 1989. When the skiing season is over, our main hobby is sailing on the Chesapeake Bay where we have had the same pretty blue sailboat called the POCAHONTAS for over thirty years. Before moving to Washington, we sailed mostly on Lake Erie. Our most memorable sailing experience was a six week cruise around three of the Great Lakes that we took in 1972.

John first learned to ski at Mt. Sunapee, NH. during the winter of 1959/60. Most of his skiing was learned at Seven Springs about 35 years ago when it was still a quaint little place with rope tows and poma lifts. The most memorable skiing adventure (still remembered with terror) occurred at St. Anton, Austria while still a quite inexperienced skier making stem turns. On two separate occasions, he managed to find himself on a horrible trail called LiftLine that had moguls at shoulder height and no way to escape except to go straight down them for about 3 kilometers. I recently learned that these moguls are still there and are still as large as they were more than 35 years ago. A favorite ski area is St. Moritz in Switzerland.



Blue Ridge Ski Council Meeting, Solomons Island, Md. May 18th & 19th (Continuation from June Toot)

Three hundred and nine people went on the Western Winter Carnival trip to Lake Louise, Canada . Everything went well, and the group got a surprise dinner at the Chateau Lake Louise. The skiing was good, but not excellent. Several clubs went to Kicking Horse and reported that the ski area is still a couple of years away from becoming a destination resort. It is owned by a Dutch Consortium, and they have yet to add snow making and to build base lodging.

Delicious Recipes from the Spring Dinner

Pecan Wild Rice Pilaf

3 cups chicken broth	½ cup chopped fresh Italian parsley
1 cup wild rice, well rinsed	½ cup chopped fresh mint leaves
1 ¾ cups wheat pilaf (2 pkgs Taboule Wheat Salad)	Grated Zest of 2 oranges
1 cup pecan halves, toasted	2 tablespoons olive oil
1 cup dried currants	1 tablespoon orange juice
1 bunch scallions, thinly sliced	Freshly ground black pepper

1. In a medium saucepan, bring broth to a boil. 2. Add wild rice to boiling broth. Bring back to a boil, reduce heat to medium low and cook, covered, for 50 minutes or until rice is tender. Do not overcook. Remove to a large bowl. 3. In another saucepan, bring 2 ¼ cups of water to a boil. Stir in the pilaf, cover and bring back to a boil. Reduce heat to low; simmer 15 minutes, until pilaf is tender. Remove from heat, let rest 15 minutes and add to the wild rice. 4. Add remaining ingredients and toss well. Serve at room temperature.

Marinade for Pork Tenderloin

2 inch piece ginger, peeled
4 large cloves garlic
¼ tsp. Tumeric
1 tsp chili powder
¼ cup plain low-fat yogurt
1 tbsp fresh lime juice

Blend ginger and garlic to fine paste in blender or food processor., Add remaining ingredients and process until combined.

FRESH COCONUT POUND CAKE

1 cup butter softened	1 tsp coconut extract
3 cups sugar	1 tsp vanilla extract
6 eggs	
3 cups all purpose flour	ICING:
¼ tsp baking soda	½ cup butter, softened
¼ tsp salt	1 pound box confectioner's sugar
1 carton (8 oz) dairy sour cream	¼ cup water
1 ¾ cups fresh coconut	1 tsp vanilla

Cream together butter and sugar; beat until mixture is light and fluffy. Add one egg at a time, beating well after each addition. Combine flour, soda and salt, mix well; add to creamed mixture alternately with sour cream, beginning and ending with flour mixture., Stir in coconut and both flavorings. Pour batter into a greased and floured 10-inch tube pan. Bake at 350 for 1 hour and 20 minutes or until a wooden pick inserted in the center comes out clean. Cool in pan 10-15 minutes; remove from pan and cool completely before icing or cutting. To make icing, combine all ingredients in large bowl and mix at high speed until fluffy. Frost top and sides of cake. Sprinkle with coconut. Serves 16.
