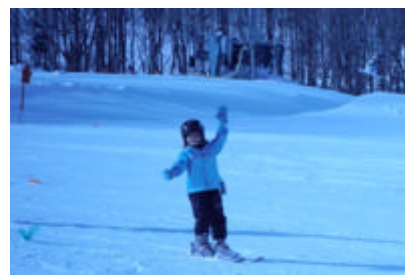

Happy New Year and here's to a great ski season!

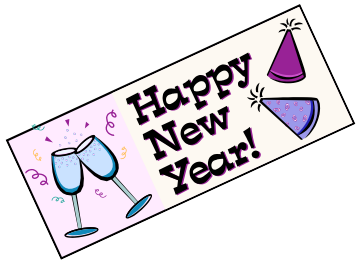

Directions: check your maps

From Washington, DC via Chain Bridge

Take Chain Bridge onto N. Glebe Rd., crossing into Virginia. Go straight (not turning right on Chain Bridge Road). As you go up the hill to Glebe Road, do not take the turnoff to Military Rd. At the top of the hill after a big curve, the first right is River Street – there is a sign there that says Chain Bridge Forest. **Turn right onto River St.** Go 3 blocks on River. You go down a hill and up the next. At the top of that hill (the third left) **turn left on Highwood**. Go to the very end, about 4 or 5 blocks, ending in a cul-de-sac. We're at the back of the cul-de-sac

From the Beltway (I-495)

Take the Georgetown Pike exit (exit 44) east.

Turn left onto Route 123, Chain Bridge Road.

Turn right onto N. Glebe Road. As you go up the hill to Glebe Road, do not take the turnoff to Military Rd. At the top of the hill after a big curve, the first right is River Street – there is a sign there that says Chain Bridge Forest. **Turn right onto River St.** Go 3 blocks on River. From Virginia via the Dulles Toll Road

Merge onto Route 123 N via exit 19B toward McLean.

BAGGAGE

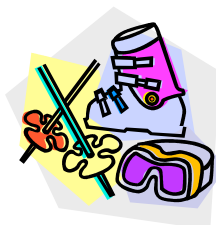
The rumor is that American Airlines is considering changing their boot bag+ski bag = one bag policy. If this goes through they will consider your suitcase as a bag (\$25 each way), your ski bag as a second piece (\$35 each way), and your boot bag as a third piece (\$100 each way). The three bags would cost the skier \$320 round trip!!! Please check with your airline and be sure you understand their baggage policy. We recommend putting your boots with your clothing or taking as carry on. Also, look into sending your skis by Fed Ex or UPS.
