President's Message



When I first joined PVS many years ago, the Club ran at least one other trip besides Snowmass. In fact, Bob and I were the trip leaders for several trips to Steamboat and Park City, and an ill-fated trip to Mt. Bachelor, where it rained all week (the locals said it had never happened before). We simply do not have the mass of skiers or the interest anymore to offer more than our Snowmass trip. Fortunately, that trip is still very well attended and ably led by our excellent trip leaders, Kathy and Barry Lake.

If you are looking for another ski trip this season, don't forget that PVS can go on any of the ski trips run by one of the ski clubs in the Blue Ridge Ski Council (BRSC), of which PVS is a member, as well as the ski trips run by the BRSC (by signing up with a member club). The BRSC is an organization of member ski clubs throughout the Mid-Atlantic region, and among other clubs, includes the Ski Club of Washington D.C., the Baltimore Ski Club, the Columbia Ski Club, the Frederick Ski Club, the Fredericksburg Ski Club, the Pentagon Ski Club, and the Richmond Ski Club. Each year, the BRSC contracts with a ski travel agent for two or three trips (BRSC trips), and a trip leader from each club that wishes to participate takes care of the club-specific details. Over the years, PVS members have participated, with our own trip leaders, in the BRSC trips and have met many members of the other ski clubs.

To access information about these trips, go to the BRSC website (<https://www.ski-council.com>), and click on the link "Sanctioned Trips." There you will first find the list of the three BRSC trips this season, followed by a listing of the other ski trips run by the member clubs, with information on the price, covered items, and availability. Wherever you want to go, one of the BRSC clubs may well be running a trip.

This year, the BRSC trips include Lake Tahoe from February 3 – 10, Kitzbühel, Austria from March 15 – 23, and Sunday River, Maine from March 3 – 8. If there is availability, you can sign up with one of the clubs going on these trips. There are a multitude of other trips run by the BRSC-member ski clubs.

For example, the Ski and Sports Club of Washington DC (also known as the Ski Club of Washington) is running a trip to Taos from March 2 – 9. The cost is \$2775, which includes airfare from DCA (it's early at 6:55 am), ground transportation, seven nights lodging at the Inn at Snakedance (in two-bedroom units), a very nice hotel right at the base of the mountain, one group dinner, and six days of lessons (3 hours/day). Lift tickets are not included in the price. Taos is an iconic area 26 miles from the town of Taos with many very challenging slopes but also terrain for intermediate skiers. Bob and I have participated in their ski instruction week many times and highly recommend their program. Basically, you have a lesson every morning and then free time in the afternoon to ski on your own. There is still availability for this trip.

The Ski Club of Washington is also offering a January 20 -27 trip to Park City for \$2335, including seven nights at the YotelPAD Park City (located at the base of the Canyons), airfare from DCA, ground transportation to Park city, a welcome reception, and shuttle service to Park City and Deer Valley. Lift tickets are not included. Other January Ski Club of Washington trips are to Jackson Hole, Whitefish, and Snowbird; their February trips include Beaver Creek, Mt. Bachelor, and Mammoth Mountain. In March, they are going to Big Sky and Aspen.

Other clubs have trips listed for a wide range of ski resorts, both domestic and foreign, including Telluride, Whistler, Revelstoke (Canada), Mt. Tremblant (Canada), Panorama (Canada), Keystone, Fernie (Canada), Schweitzer (Idaho), Zermatt (Switzerland), Ogden (Utah), Snowbird, Cervinia (Italy), and Winter Park. Of course, space is limited on many of these trips. If you are looking for a late season trip, the Frederick Ski Club is offering an April 6 – 13 trip to Mt. Bachelor for \$2189. Included are airfare, ground transportation to Bend, seven nights lodging at the Double Tree in Bend, daily breakfast and a 5-day lift ticket. You never know – it might not rain.

The bottom line is that if you are looking for a pre-arranged trip, where you are likely to be able to find a group of people at your level with whom to ski and enjoy apres-ski activities, consider the large variety of trips offered by the BRSC member clubs.

PVSers are still reading! It's time to get ready to sit by the fire with a good book as the weather cools down. We'd love to have you join us to chat about what we've been reading. It's always interesting hearing what our friends enjoyed - or didn't. See below our new rating system of 1 to 5 stars for clarity about our recommendations. **See the info at the bottom to join in next time on Thursday, October 12th from 4 to 5 pm.**

Here's what we discussed in September:

Bonnie Sweeney, after her momentous move to Michigan, still had time to read "Mad Honey" by Jodi Picoult and Jennifer Finney Boylan. Part murder story, part tale of personal growth, the novel centers on two women, one a beekeeper, who move to a small town to start new lives. **4***

Marianne Soponis brought us the famous detective Easy Rollins in the crime novel "Blood Grove" by Walter Mosley. Rollins takes the case of a white Viet Nam vet who fears he killed a black man in a fight while protecting a white woman. Marianne particularly appreciated Mosley's descriptions of racially charged Los Angeles in the 1960s. **4***

Karen Knopes recommends "The Summer Before the War" by Helen Simonson. Simonson's story is set among the gentry in 1914 England as the country is on the brink of war. Unfolding slowly and steadily like one by Jane Austen, the novel shows how society experiences the rise of feminism and the changes brought on by WWI. **4***

Ellie Thayer has been reading and reading and reading the lengthy "Enlightenment Now" by Steven Pinker. Pinker's premise is that the Age of Enlightenment is still with us as shown by the myriad improvements in the lives of most. With numerous examples, Pinker says we should focus on the positives that continue and not feel demoralized nor that all positive progress has ended. **4.5***

Jan Marx listens regularly to books and recently focused on "Two Old Broads" by M.E. Hecht and Whoopi Goldberg. Hecht is a well-known 90-year-old surgeon and expert on aging who opines on managing aging and what has made her and others manage the process so well. Whoopi Goldberg shares authorship and provides her brand of amusing commentary. **3***

Nancy McKinley read "The Great Believers" by Rebecca Makkai. Makkai sets her novel in both Chicago's gay community during the worst of the AIDS epidemic in the 1980s and in Paris in 2015 where a woman whose beloved brother died of AIDS is searching for her missing daughter. Makkai weaves in historical characters and events in this affecting story. **4***

SKI TALK



Fall is officially here and that means that ski season is just around the corner! Some ski areas have already seen their first snow of the season. The Loveland Ski Resort in Colorado isn't taking any chances and has already started the snowmaking process. They are in a race with Arapahoe Basin to be the first to open up in late October/early November. Time will tell who gets that honor.

A solid snow year is predicted for the upcoming ski season in the Aspen/Snowmass area. AspenWeather.net is predicting snowfall this winter that's 15% above the average for local ski mountains. Its meteorologist reports that a special "Modoki" El Niño phenomenon this winter will bode well for skiers. (Modoki is Japanese word meaning similar, but different.) Modoki El Niño winters have occurred five times since 1990. In those five years, Aspen has seen an average of 10% more snowfall than normal. The Modoki El Niños tend to drive the jet stream south of its usual course, pushing storms across central California and Colorado. So, there should be plenty of snow waiting for us in January.

According to the Explore travel website Colorado has the best skiing in the U.S. The nation's number one skiing destination is no surprise due to its immensely wondrous mountain ranges and ski resorts. The Rocky Mountains and plentiful snowfall create the perfect atmosphere for any skier's dream destination.

Thinking about upgrading your ski equipment? The Alpine Ski Shop has a **Ski Swap** on Oct. 21st & 22nd at the **Sterling, Va location**. It's an opportunity to swap gently used skis, snowboards, skates and/or ski jackets & pants for newer ones. They **do not** accept goggles, helmets, broken or damaged equipment, straight skis or skis with obsolete bindings. The drop off period is from Oct. 9 – 19. If your equipment does get sold you will receive a store credit for the sales price to purchase any new equipment, clothing or accessories sold at the Alpine Ski Shop on Monday, Oct. 23rd. Once again, we will be staying at the [Snowmass Mountain Chalet \(SMC\)](#), which offers a convenient ski in, ski out location. The **“LAND ONLY”** package includes: transportation to and from Aspen airport; 5-day Senior (65 and older) lift pass ([good for all four ski areas in the Aspen complex, free shuttle bus](#)); 7 nights lodging (double occupancy); luggage handling; buffet breakfast, soup lunch, welcome reception, pizza party and farewell group dinner to celebrate our trip. Additional nights at Snowmass are an option **based on availability**.

Trip insurance is available through www.Encompasse.com and is [highly recommended](#).

The Basic Package price is based on 2 people per room. We have 20 rooms reserved consisting of Standard and Deluxe, King and Queen/Queen rooms. Island Hopping in Greece

Our summer trip this year included Bulgaria and Greece. Typically, when it is too hot to think about skiing, I can only think about sinking my toes in the sea and enjoying a sandy beach. Regrettably, Nick is no beach aficionado and prefers the shade, as far from the sand as possible. I've been promising him a mountain hike in Bulgaria for years, but somehow, the beach always wins.

Although lounging lazily in the sand, splashing in the sea, and feasting with friends in Bulgaria was great, this account will focus on our visit to Greece. If and when the mountain hike in Bulgaria happens, I might outline that experience in a future TOOT.

Our Greek escapade began in sunny Crete, ready to spend a week with some of my high school friends who jetted in from Australia, Europe, and America. Cheers to long-lasting friendships that cross continents! We all stayed in the splendid house of one of these lovely friends and spent long hours chatting and laughing by the pool and enjoying the wonderful views from the house. But Crete has much more to offer. We enjoyed its picturesque villages, beautiful coastline and seas, and a menu that read like a culinary symphony. And there are so many layers of history to appreciate. Don't even get me started on the artistry of the ancient craftsmen exhibited in the Archaeological Museum in Heraklion—it's a must-see!

Next up was Athens. The trip there turned out to be quite a wild ride! We thought that Zeus himself had orchestrated our dramatic arrival. Thunderstorms and torrential rain conspired to significantly delay our flight, and when we finally arrived close to midnight, a boat might have been more appropriate than the taxi navigating us to our hotel. It was a scary taxi ride through rivers of water, but we survived! Zeus continued his tricks on the following day as we walked soggy streets and slippery sidewalks, culminating in a visit to the Acropolis in a downpour. But who says that travel can't be an adventure? The following days arrived with glorious weather, and we enjoyed long strolls through old Athens, and a visit to the remarkable Acropolis Museum (another must-see!). Oh, and did I mention the Greek cuisine that perfectly fitted my pescatarian tastes and was accompanied

by generous servings of ouzo and wine at charming tavernas?

The grand finale of our Greek journey was a boat and bike tour. We had previously tackled similar adventures with the same company in Croatia (thanks, Rosemary, for your recommendation!). This year, the plan was to explore the Cyclades and Saronic Islands, but Poseidon had a change of heart. To avoid rough seas, we ended up pedaling our way through the Peloponnese Peninsula and the islands of Spetses, Poros, Hydra, and Aegina. Our vessel, the *Thalassa*, was a beautiful three-masted Turkish Galette, and our shipmates included a merry crew of Canadian pilots, couples from

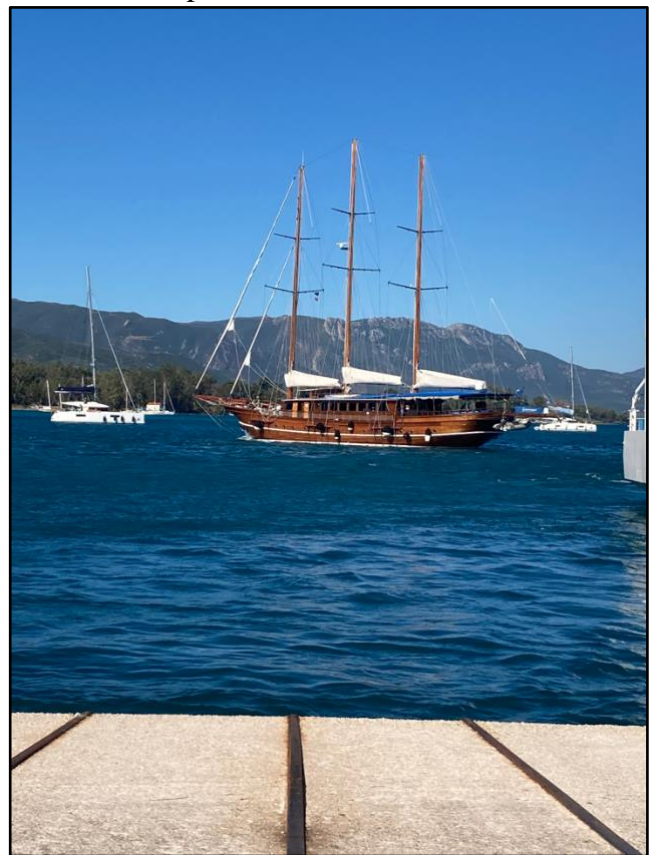




Argentina and Germany, a Canadian-turned-Nashvillian, a Californian artist turned Canadian from British Columbia, and a New Yorker former dancer now residing in Montana. It was a vibrant, fun-loving group! To top it off, we had an onboard chef who performed culinary magic. Thank goodness for the calories we burned biking; otherwise, our added weight would have sunk the boat. We pedaled roughly 140 miles, taking in breathtaking vistas, charming villages, and, of course, more delicious food, with the occasional dip in the sea to cool off. Full disclosure, Nick and I rode e-bikes, but we were not alone; in fact, after just one day, the only brave soul in our group who had chosen a regular bike joined the e-bike ranks, such was the terrain!

As we bid Greece adieu, we spent our final night in a sumptuous resort hotel, not too far from Athens' airport. Our room came complete with its own little infinity pool, in addition to the resort's pool and beach by the sea. A fitting farewell for the beach lover in our clan, wouldn't you say? Nick had his suspicions that my motive for booking this hotel wasn't its proximity to the airport but rather the allure of the

beach. Still, he did admit that a second night there would have been rather splendid. Alas, our feline friends at home were eagerly awaiting our return, and the call to return was too strong to resist. And after almost two months, stepping back into the comforts of home does feel good.

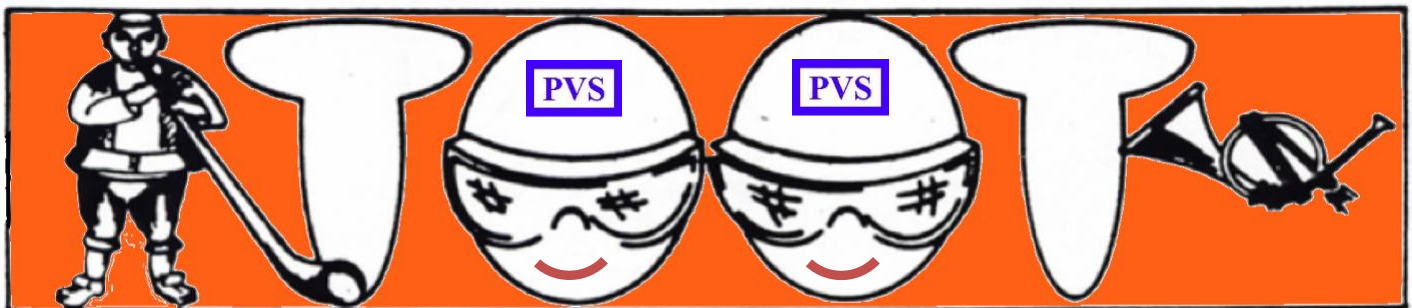
Great New Job Opportunities

I am announcing that I am retiring as TOOT coordinator in March 2024. I have had a 14-year run and it has been fun, I have worked with great people, and I've learned more than I've given, but it is time to pass the torch. Also, Dave Warthen, one of TOOT's three revolving layout editors, is retiring from his position at the same time.

The club is looking for replacements for the TOOT coordinator and one layout editor. To aid in the search, the following are brief descriptions of our responsibilities. The TOOT coordinator starts the enterprise rolling by sending out a mid-month reminder, around the 15th of the month, to all those who are known to be contributing articles. Other contributors may follow. The reminder sets forth a final due date for articles to be sent to the coordinator, i.e., four days from the last day of the month (including a count of the last day). As an article arrives, the coordinator reviews it and edits it, if appropriate, and sends it to the designated layout editor for the month. Within the last four-day period, the layout editor works his or her magic (see below) and returns a draft TOOT to the coordinator for a final review. The final TOOT goes to Dave Warthen for a final review as he readies it for uploading to the website. When all is in good shape, it is sent to Barry Lake who distributes it electronically to the members on the 1st of the month.

There are presently three layout editors who are on a regular monthly rotation. Two editors are responsible for four months each and one is responsible for three months and possibly an August supplement, if there is one. (In recent years, we have not issued an August supplement and any needed news is sent by an e-blast by Barry.) A layout editor's basic responsibility is to take the draft documents, photographs, and selected supplementary art and formatting the whole into an attractive and enticing product using MSWord and then converting the resulting product into a pdf for distribution to the membership. While not particularly complicated, the process requires a modicum of skill to insert photographs into text, add annotations to photographs when needed, determine appropriate pagination, occasionally format tables and text boxes and, finally, reduce file size without losing presentation quality.

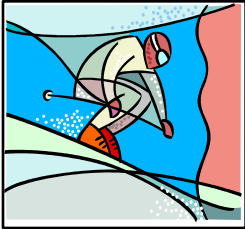
