

area. While it doesn't transmit Lyme disease, it can cause alpha-gal syndrome, which can cause the bitten to become allergic to the consumption of all red meat! And its bite also doesn't leave a tell-tale sign like the deer ticks bullseye either. ### Directions to the home of Cara and Robert Jablon, 4573 Indian Rock Terrace, N.W., Washington, D.C.:

**From Northwest D.C.:** Take Nebraska Avenue to the beginning of Foxhall Road. Go south on Foxhall Road one traffic light past the intersection of Foxhall and Reservoir to Q Street. Right on Q Street. Continue on Q Street for 1 block to the stop sign (45<sup>th</sup> St.) and make a right on 45<sup>th</sup>. Go two blocks and make a left (Q Lane). The street will dead end into Indian Rock Terrace. Make a right and go up the hill. The Jablons' house is the fourth house up the hill on the right (a red brick and frame contemporary house).

From Potomac/Rockville/Gaithersburg: Take 270 South to 495 towards Virginia. Exit at Cabin John Parkway and continue south on the parkway until Arizona Avenue (1st traffic light after light at Chain Bridge). Make a left on Arizona and a right on MacArthur Boulevard (1st light). Continue on MacArthur Boulevard for about 1½ miles past the Safeway on the left. Shortly after passing the Safeway, MacArthur forks to the right and Reservoir Road goes to the left. Continue on MacArthur to Q Street (the next light after the light at the fork). Make a left on Q Street. Go 1 block to the stop sign (45th St.), and make a left on 45th. Go 2 blocks and make a left (Q Lane). The street will dead end into Indian Rock Terrace. Make a right and go up the hill. The Jablons' house is the fourth house up the hill on the right (a red brick and frame contemporary house).

**From Virginia (Chain Bridge):** At the end of the Chain Bridge, make a right. Continue to the first light (Arizona Avenue). Make a left on Arizona and follow the directions immediately above from that point on.

**From Virginia (Key Bridge):** Stay in one of the left lanes at the end of the Key Bridge. Make a left at the end of the bridge to M Street (may be called Canal Road at that point). Get in the right lane and continue up the hill to the light at the beginning of Foxhall Road. Continue on Foxhall to the next light (Q Street). Make a left on Q Street. Go one block to the stop sign (45<sup>th</sup> St.) and make a right. Go 2 blocks and make a left (Q Lane). The street will dead end into Indian Rock Terrace. Make a right and go up the hill. The Jablons' house is the fourth house up the hill on the right (a red brick and frame contemporary house).

### Here are the books we shared in May:


- Mary Ellena Ward brought us "The Invention of Wings" by Sue Monk Kidd, a fictionalized account of real abolitionist Sarah Grimke and the slave, Hetty, who was given to Sarah on her 11<sup>th</sup> birthday. Their relationship grows and becomes one that fights for the abolition of slavery amid the denial of the rights of women.
- <u>Ingrid Dallaire</u> told us about "The Making of Asian America: A History" by Erika Lee. Lee writes a comprehensive history which Ingrid described as life changing. Chinese immigrants were instrumental from the early days of our country and those of Chinese heritage continued to play a prominent yet often unacknowledged or misunderstood role in the growth of the United States.
- <u>Bonnie Sweeney</u> discussed "The Seed Keeper" by Diane Wilson. The story spans several generations of women in a family of the Dakota people in Minnesota. The author explores the values of tradition and family and the protection of the Dakota heritage through their cherished cache of seeds.
- <u>Karen Knopes'</u> contribution also related to the cultures of Native people in the United States.
   Author Louise Erdrich shone a light on rural people combating continuing efforts by the government
   to erase Native American protections in "The Night Watchman". This contrasted with "There,
   There" by Tommy Orange which laid out some of the difficulties experienced by Native urban
   people in contemporary America.
- <u>Ellie Thayer</u> turned to the extraordinary true story of Virginia Hall in "A Woman of No Importance" by Sonia Purnell. Despite losing a leg and being that rarity a woman spy Hall operated undercover during WWII working with UK Intelligence then the OSS followed by the CIA. Her exploits are legendary even while working for men of questionable competence.
- <u>Nancy McKinley</u> discussed Hanya Yanagihara's "The People in the Trees" a fictional tale of a researcher's work on a remote island whose Indigenous population had discovered the secret to immortality. The flawed protagonist proves that one doesn't have to like the main character to be fascinated by excellent writing and a riveting story.

### ???ANYONE WANT TO CONCERT???





### SKI TALK JUNE 2022

On June 1, we will be in Oslo just off the ferry from Copenhagen. We are looking forward to traveling again and hoping all goes well. This is our first major trip since the pandemic started March 2020. According to



our sources, Scandinavia is "over" COVID. They no longer require masking or testing, but we do have to test to get back into the US.

There have been major changes in the travel industry over the past two years, according to the vendors who plan our group ski trips. Doug Horstman and Mike Agnew, who organize many of the club's ski trips, were both commenting at the recent BRSC meeting that not only are the airlines charging more for groups, but also it is difficult getting seats. Flights get cancelled without much

notice and airlines have reduced flights into many of the resorts. The main problem with setting up extensions for the Val d'Isère trip is the rising costs of ground transportation. Many tour bus companies went out of business and those still in business are charging high rates, both overseas and in the US. According to Mike Agnew, who ran the BRSC trip to Jackson Hole last season, it was a nightmare scheduling buses to take skiers from their hotels in town to the resort.

Even more important is what is happening at the ski resorts. Vail lost over 50% of their staff during the pandemic, and the new office hires don't understand group travel and ski clubs. Pre pandemic, resorts were happy to book ski groups during the week and in low season. However, they have now found that more individuals have flexible work schedules and are filling up the resorts throughout the season. The market has changed and the resorts are not as welcoming to clubs.

This is presenting a problem for future planning of BRSC Western Carnival and



Eurofest trips. The BRSC Western Carnival 2024 was supposed to be at Whitefish, but difficulties with air and buses are making that impossible. At the recent BRSC meeting, Snowbird was selected as the new destination but that could change. It was suggested at the meeting that rather than the Council picking a location, the vendors should make recommendations about which resorts would work for large BRSC groups.

So many things have changed in the past two years during the pandemic. It may take a few years to get it all worked out. In the meantime, we are looking forward to Snowmass and Val d'Isère in 2024. See fliers in this TOOT.

### **The Mountain Chalet**

The **Snowmass Mountain Chalet** is an independent lodge, managed on-site, with easy access to the slopes. Each of the 64 rooms has either 2 queen beds or 1 king bed, **depending on availability**. All rooms have: hair dryer, TV, small refrigerator, etc. The lodge has a nice lounge on the main floor with chairs, game tables, fireplace, and large windows overlooking the slopes. There is an elevator, exercise room, outdoor pool, a hot tub and laundry facilities. A full breakfast is served family style each morning. The Snowmass Mall, on the level above, and the hotel area below (via the small gondolas) have diverse restaurants at all price levels. Bus service stops are nearby for trips to a nearby grocery store, into the town of Aspen, to other Aspen ski areas, and to Glenwood Springs.

### **Trip Insurance**

**Trip insurance is highly recommended and should be purchased shortly after sending in your deposit.** Travel Guard is available through our travel agent, Encompasse Tours, at **Encompasse.com**. Be sure to identify Encompasse Tours as the Tour Operator at the appropriate spot on the registration form so that AIG/Travel Guard can certify the policy and interact with our vendor in the event of a claim. #### **Cancellation Policy and Fees**

If it becomes necessary for you to cancel your trip, the trip leaders will try to minimize your losses, although some fees are mandated by the hotel and tour operator. All cancellations must be in writing. We strongly urge you to purchase trip insurance (see above).

Please take the time to ensure the information you provide is correct, and take note of deadline dates!

<u>Cancellation fees are as follows:</u> <u>Dates and costs are consistent with requirements and penalties imposed by vendors per contracted agreements.</u> <u>LAND Only Package</u>: The entire cost of the trip is non-refundable after October 15<sup>th</sup>.






Barry Lake called for the meeting to start and thanked Ingrid for hosting the meeting at her
